- 3: Increase revenue for YCC

YCC POD Rules and Regulations

Each POD must consist of one current “member” of YCC in good standing, and up to (2) non-members of YCC. A minimum of (2) individuals and a maximum of (3) individuals will comprise a POD. A non-member can be ANYONE not currently in any membership level within YCC, regardless of how long they have not been part of the YCC membership.

As each current member adds more non-members to their POD, the cost of membership decreases for each member of the POD.

Each POD will last 36 months from the origination date, and the price of membership will be LOCKED IN for the entirety of the term. If there is an addition (if applicable) or subtraction of a participant within the POD during the term, membership pricing will adjust to corresponding level for the remainder of the term based on origination date. Subtractions from a POD due to long-term illness, death, change of residence, etc. will be discussed by the board on a case by case basis and the remaining POD members will have a grace period to potentially re-fill their POD if they so choose.

Each member of the POD will sign a written agreement to maintain their status within the POD for length of the term and lock in pricing for the duration of the term. All non-POD members at YCC (full golf and potentially social) will be subject to potential yearly dues increases as the board of directors sees fit. Members within a POD system are not subject to those increases over the course of their term. All members (POD and non-POD) are subject to assessments as the board sees fit.

The \$25/monthly minimum will still apply to the appropriate membership and will be in addition to the membership pricing.

POD's will be limited on types of memberships. In-county golf membership POD's will encompass: full membership levels, single memberships, young professional memberships, junior memberships, and senior memberships. Out of County and

Social membership will remain the same. POD's will not be available for out of county and social members at this time.

At the conclusion of their 36 month term, each member of the POD will have two choices: Return to full member pricing at their respective membership level, or initiate a new POD with non-members who have not had any YCC membership status for at least 1 calendar year prior to new POD starting.

If a member of a POD decides to forfeit continued membership after the term of their POD expires, they must wait one (calendar) year before applying for a new POD membership. They also will be subject to a \$100 stock fee and \$500 initiation fee before they will be accepted for re-membership

Early termination of a POD will result in all members either returning to their corresponding membership level pricing, or paying "POD" rates for the remainder of their 36 month term. This will be dependent upon the circumstances and a decision will be made by the board accordingly.

****Disclaimer:** This document is by no means exhaustive, but gives the base rules regarding the POD membership system. Any discrepancies/matters/issues concerning POD's and membership not covered within these rules and regulations will be discussed by the Board of Directors and decided upon as needed.

If there is an addition (if applicable) or subtraction of a participant within the POD during the term, membership pricing will adjust to the corresponding level for the remainder of the term based on the origination date.

The \$25 restaurant/bar monthly minimum will still apply to the appropriate membership and will be in addition to the membership pricing.

All members (POD and non-POD) are subject to assessments as the board see fit.

All members of POD must keep their membership account status current, any account 60 days past due will be considered delinquent, membership dues will return to full rate until all members of the POD are current.

All new members must fill out and sign a membership application.

Early termination of a POD will result in all members either returning to their corresponding membership level pricing, or paying "POD" rates for the remainder of their 36 month term. This will be dependent upon the circumstances and a decision will be made by the board accordingly.
