Grounds Committee Report Drainage project on #5 is on hold as it may be fixable by Shad and his staff. They are going to work on smaller improvements that may have been overlooked. Looking at a 5K budget on repairs.

Drawings presented on getting the back 9 irrigation up to speed and fill in where areas are being missed on the front 9. Currently the staff spends at least 20 hours a week moving hoses to accommodate water needs. Overall investment would be 73K but looking to see if all areas would be done at once after considering adding some trees. Areas would be knifed in rather than trenched like before. Motion by Cody to move this this project forward was made, 2<sup>nd</sup> by Barry; motion passed.

2 loads of white sand coming to add to bunkers and continue to replace a little each year. (#3 and #18 greenside)

Removal of white fence on #3 and wording in scorecard to be done. Doesn't serve any purpose.

Greens aerated and rough all mowed.

Marilyn Jackman is inquiring about a way to donate in her late husband's honor. Looking into nicer water cooler structures to add to the course. Will get quotes and visit about this idea.
